**RECOMMENDING EXEMPTION FROM ITEM 1(d) OF MEMORANDUM ORDER
2018-06 THE PROCUREMENT OF IT EQUIPMENT BY THE PSA-REGIONAL
OFFICES AS PER OFFICE MEMORANDA 2018-164 AND 2018-151**

WHEREAS, Memorandum Order No. 2018-06 dated 29 September 2018 decentralized the procurement of the Philippine Statistics Authority (PSA) to the PSA-Regional Offices and defining the delegation of authority and designation of the Regional Director as Head of Procuring Entity (HOPE);

WHEREAS, Item No. 1(d) of the said Memorandum Order, prescribed the coverage of the decentralized procurement and specifically excludes, among others, the procurement of equipment and facilities with an Approved Budget of the Contract (ABC) of at least Php200, 000.00 which are to be under the PSA-Bid and Awards Committee (PSA-BAC) constituted pursuant to Special Order No. 2018-07ONS-1062A dated 15 August 2018;

WHEREAS, Office Memoranda No. 2018-164 dated 18 October 2018 and 2018-151 dated 13 September 2018 provided the Regional Offices with the necessary IT requirements in support for statistical and census operations, with corresponding budget exceeding the Php200,000 limitation per region as prescribed in Memorandum Order No. 2018-06;

WHEREAS, the field offices have expressed their requirements for additional IT equipment to support their statistical, civil registration and administrative functions and activities;

WHEREAS, these additional IT equipment will be submitted to DICT for inclusion in the amendment in the ISSP of PSA for 2018;

WHEREAS, savings in Capital Outlay are generated out of the bidding of IT equipment for CPBI and CPH purposes;

NOW THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED, to recommend to the National Statistician and Civil Registrar General, that the procurement of IT equipment by the Regional Offices as per Office Memoranda 2018-164 and 2018-151, for practical consideration since the budget was already transferred to the Field Offices and since further fund transfer will be done pursuant to field office requirements be exempted from Memorandum Order No. 2018-06.
