

**RBAC Resolution Declaring the Lowest Calculated and Responsive Bidder and
 Recommending Award of Contract
 RESOLUTION NO. 2019-005**

WHEREAS, Philippine Statistics Authority Regional Bids and Awards Committee of BARMM posted the Invitation to bid for Desktop Computers in PHILGEPS and bulletin boards continuously for twelve (8) days from May 29 – June 5, 2019;

WHEREAS, on 6 June 2019, the Regional Bids and Awards Committee (RBAC) held the pre-bid conference which was attended by two (2) prospective bidders, DIGITAL INTERFACE and MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES;

WHEREAS, on 11 June 2019, the RBAC Chairperson issued Notice of Postponement for opening of bids from 19th of June 2019 schedule, it was moved to 24th of June 2019 in view of the official travels of RBAC chairperson and members;

WHEREAS, on 18 June 2019 before the 2pm, closing time of receipt, DIGITAL INTERFACE and MILLENIAL TECH submitted the required bidding documents.

WHEREAS, on 24 June 2019, 2pm, the scheduled opening of bids, MILLENIAL TECH passed the preliminary examination of bids which includes the technical specification and eligibility requirements, while on the other hand, DIGITAL INTERFACE failed the preliminary examinations due to violation of Section 25.2.vii of Revised IRR of RA 9184 and Section VII of the Bidding Documents, Technical Description and Specifications.

WHEREAS, the bid proposal of MILLENIAL TECH was found to be substantially complying:

WHEREAS, upon careful examination, validation and verification of all the eligibility/technical and financial requirements of MILLENIAL TECH, was found to be responsive and thus post-qualified;

NOW, THEREFORE, the Members of the Regional Bids and Awards Committee hereby resolve as it is hereby RESOLVED:

- a.) To declare MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES as the lone bidder with substantially calculated Bid which amount below and in line with the approved budget of contract;
- b.) To recommend for approval by the Head of Procuring Entity of PSA-BARMM, the award of contract for DESKTOP COMPUTERS to MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES;

RESOLVED, at the PSA-BARMM, Cotabato City, this 26th day of June 2019.

If the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as the bidder with the Lowest Calculated Responsive Bid, and the head of the Procuring Entity concerned shall award the contract to the said bidder. (IRR-A Section 34.3) The TWG, with the assistance of the Secretariat, if necessary, shall prepare the BAC Resolution declaring the LCRB.


