## RBAC Resolution Declaring the Lowest Calculated and Responsive Bidder, Reposting of Failed-Bidding and Recommending Award of Contracts RESOLUTION NO. 2019-009

WHEREAS, Philippine Statistics Authority Regional Bids and Awards Committee of BARMM posted the Invitation to bid of 2020 Supplies and Materials for Census of Population and Housing (2020 CPH) Project of PSA-BARMM in PHILGEPS and bulletin boards continuously for Eight (8) days from November 19 – 26, 2019 with the following details, to wit:

WHEREAS, on 22 November 2019, the Regional Bids and Awards Committee (RBAC) held the prebid conference which were attended by six (6) prospective bidders, 3M PHILIPPINE INC., KHALIF GENERAL MERCHANDISE, MINDSET DESKTOP & PUBLISHING SERVICES, JANNA HARDWARE, DIGITAL INTERFACE AND MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES.

WHEREAS, on 6 December 2019, MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES, THRIFTY ENTERPRISE AND MINDSET DESKTOP & PUBLISHING SERVICES acquired Bidding documents, on 9 December 2019, DIGITAL INTERFACE acquired bidding documents;

WHEREAS, on 6 December 2019, MINDSET DESKTOP & PUBLISHING SERVICES submitted bidding documents without proper labelling, on 9 December, THRIFTY ENTERPRISE submitted the bidding documents without proper labelling and MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES submitted bidding documents for Lot 1- Common Used Office Supplies, Lot 3-Enumerator's Bag, Lot 4- Umbrella, Lot 5- Rain Coat, Lot 6- Cap, Lot 7- Tshirt and Lot 10- Vest;

IF BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder with the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder. WHEREAS, DIGITAL INTERFACE failed to submit the bidding documents on the required time of submission and, thus, disqualified on the bidding process;

WHEREAS, RBAC of PSA-BARMM found out that there were no bidders on LOT 2 – Identification Card, Lot 8 – Clip Board and Lot 9 – Tumbler;

WHEREAS, on 10 December 2019, 2pm, the scheduled opening of bids, MILLENIAL TECH bids for Lot 1- Common Used Office Supplies, Lot 3- Enumerator's Bag, Lot 4- Umbrella, Lot 5- Rain Coat, Lot 6- Cap, Lot 7- Tshirt and Lot 10- Vest passed the preliminary examination of bids which includes the technical specification and eligibility requirements, while MINDSET DESKTOP & PUBLISHING SERVICES and THRIFTY ENTERPRISE failed the preliminary examinations due to violation of Section 25.2.vii of Revised IRR of RA 9184 and Section VII of the Bidding Documents, Technical Description and Specifications, and, thus, disqualified on the bidding process;

WHEREAS, the second envelopes were opened, financial bid proposal of MILLENIAL TECH were found to be substantially complying:

To recommend for approval by the Head of Procuring Entity of PSA-BARMM, the award of contract on Lot 1- Common Used Office Supplies, Lot 3- Enumerator's Bag, Lot 4-Umbrella, Lot 5- Rain Coat, Lot 6- Cap, Lot 7- Tshirt and Lot 10- Vest, Supplies and Materials for 2020 CPH Projects to MILLENIAL TECH COMPUTER AND OFFICE SUPPLIES;
- c.) To declare failed bidding and re-advertisement of LOT 2 Identification Card, Lot 8 Clip Board and Lot 9 Tumbler, the mentioned lots shall be posted in Philgeps for another seven (7) days upon approval of this resolution.
