**This Contract is made and entered into by and between PHILIPPINE STATISTICS AUTHORITY-BARMM, located at Carumba building, Jupiter Street, RH-9, Cotabato City, represented by HJI. Razulden A. Mangelen, MPA, MDM as a OIC-Regional Director referred to the *FIRST PARTY***

- And -

**The KAMANDAG SECURITY AND MANPOWER AGENCY (KSMA) is located at 26 Austria Street, RH-10, Cotabato City, represented by Datu Tulon B. Angkal as a General Manager here in referred to the *SECOND PARTY***

**WITNESSETH**

WHEREAS, The Client is desirous of engaging the services of the Agency for all purpose of safeguarding and protecting its properties located at Carumba building, Jupiter Street, RH-9, Cotabato City.

WHEREAS, the Agency is duly licensed and authorized by the government to render services to safeguard the properties of the Client from THEFT, PILFERAGE, ROBBERY and/or the acts related there of by strangers of their person;

NOW THEREFORE, for and in consideration of the terms and conditions here in after set forth, the party here to have agreed and to contract as follows:

1. The Agency shall assign twelve (12 ) Licensed Security Guards at the said places of works for twelve ( 12 ) hours daily duty, including SATURDAYS, SUNDAYS and LEGAL HOLIDAYS. This numbers of Guards maybe increased or decreased upon the exigencies of the ser vice to be determined by both parties;
2. The Client reserves the right to reject any Security Guard who is believed to be unfit, in which event, the Agency shall immediately replace the same Guard by another Guard assigned to the Client;
3. The Agency shall provide the necessary firearms and ammunitions to each Licensed guard assigned to the Client;
4. It is expressly understood and agreed that the Guards/covered by this Contract are employees of the Agency and not of the Client;
5. The Agency shall be liable to any loss or damage sustained by the Clients on accounts of pilferage, theft and robbery committed by third minor cases. Such damage or loss shall not apply in case of fortuitous events or major force provided that the Agency shall informs its Client immediately upon discovery thereof;
6. For in consideration of the services to be rendered by AGENCY to the Client, the latter agree to pay directly to the former a monthly service fee of pesos ; **ONE MILLION, FOUR HUNDRED SIXTY-TWO THOUSAND, THREE HUNDRED TWO AND SEVENTY CENTAVOS (PHP 1,462,302.70)** and rate per guard of **FIFTEEN THOUSAND TWO HUNDRED THIRTY-TWO AND THIRTY-TWO CENTAVOS ( P 15,232.32 )** per month for twelve (12 ) hours daily duty, including Saturdays,




- 15<sup>th</sup> and 30<sup>th</sup> day of each month and,  
 7. This Contract shall take effect on **MAY 01, 2019 to DECEMBER 31, 2019** subject to renewal at the option of both parties in writing but if not, it is deemed renewed on a month-to-month basis.


